**KAYNE ANDERSON ENERGY TOTAL RETURN FUND
ANNOUNCES ITS NET ASSET VALUE AT JUNE 30, 2006**

LOS ANGELES, CA – July 3, 2006 – Kayne Anderson Energy Total Return Fund, Inc. (the “Fund”) (NYSE: KYE), today announced its net asset value at June 30, 2006.

At June 30, 2006, the Fund’s net assets were \$811 million and its net asset value per share was \$25.77 based on 31.5 million shares outstanding. The Fund’s common stock closed on the NYSE on June 30, 2006 at \$23.61. On this date, the Fund’s discount to NAV was approximately 8.4%. Accordingly, the Fund will authorize its agents to make open market purchases of the Fund’s shares consistent with the Fund’s Stock Repurchase Program announced on January 30, 2006 and extended on May 1, 2006.

Equity and fixed income investments were 87% and 13%, respectively, of the Fund’s total long-term investments of \$1.1 billion as of June 30, 2006. Long-term investments were comprised of MLPs and MLP affiliates (48%), Canadian Royalty Trusts (27%), Marine Energy Transportation (8%), Coal Companies (7%) and U.S. Royalty Trusts and Other Energy Companies (10%). At June 30, 2006, the Fund’s total assets were \$1.1 billion, which includes \$3.9 million of repurchase agreements (classified as short-term investments).
