ANNOUNCES ITS NET ASSET VALUE AT JUNE 30, 2006**

LOS ANGELES, CA – July 3, 2006 – Kayne Anderson MLP Investment Company (the “Company”) (NYSE: KYN), today announced its net asset value at June 30, 2006.

At June 30, 2006, the Company’s net assets were \$990 million and its net asset value per share was \$26.29, based on 37.6 million shares outstanding.

At June 30, 2006, the Company’s total assets were \$1.5 billion and long-term investments were \$1.5 billion. The Company’s ten largest holdings by issuer (exclusive of short-term investments) at June 30, 2006 were:
