**KAYNE ANDERSON MLP INVESTMENT COMPANY
ANNOUNCES ITS NET ASSET VALUE AT SEPTEMBER 30, 2006**

LOS ANGELES, CA – October 2, 2006 – Kayne Anderson MLP Investment Company (the “Company”) (NYSE: KYN), today announced its net asset value at September 30, 2006.

At September 30, 2006, the Company’s net assets were \$1.0 billion and its net asset value per share was \$27.13, based on 37.8 million shares outstanding.

At September 30, 2006, the Company’s total assets were \$1.6 billion and long-term investments were \$1.5 billion. The Company’s ten largest holdings by issuer (exclusive of short-term investments) at September 30, 2006 were:
