

Kayne Anderson Energy Total Return Fund, Inc. Provides Unaudited Balance Sheet Information and Announces Its Net Asset Value and Asset Coverage Ratios at March 31, 2010

HOUSTON, TX – April 1, 2010 – Kayne Anderson Energy Total Return Fund, Inc. (the “Fund”) (NYSE: KYE) today provided a summary unaudited balance sheet and announced its net asset value and asset coverage ratios under the Investment Company Act of 1940 (the “1940 Act”) as of March 31, 2010.

As of March 31, 2010, the Fund’s net assets were \$784 million and its net asset value per share was \$23.06. As of March 31, 2010, the Fund’s asset coverage ratio under the 1940 Act with respect to senior securities representing indebtedness was 450% and the Fund’s asset coverage ratio under the 1940 Act with respect to total leverage (debt and mandatory redeemable preferred stock) was 331%.

As of March 31, 2010, equity and energy debt investments were 81% and 19%, respectively, of the Fund’s long-term investments of \$1.116 billion. Long-term investments were comprised of MLPs and

MLP Affiliates (50%), U.S. and Canadian Royalty Trusts (17%), Marine Transportation (8%), Coal and Other (6%) and Energy Debt (19%).
