

Kayne Anderson Energy Total Return Fund, Inc. Provides Unaudited Balance Sheet Information and Announces Its Net Asset Value and Asset Coverage Ratio at April 30, 2009

HOUSTON, TX – May 1, 2009 – Kayne Anderson Energy Total Return Fund, Inc. (the “Fund”) (NYSE: KYE) today provided a summary unaudited balance sheet and announced its net asset value and asset coverage ratio under the Investment Company Act of 1940 (the “1940 Act”) as of April 30, 2009.

As of April 30, 2009, the Fund’s net assets were \$474 million and its net asset value per share was \$14.24. As of April 30, 2009, the Fund’s asset coverage ratio under the 1940 Act with respect to senior securities representing indebtedness was 387%.

As of April 30, 2009, equity and fixed income investments were 73% and 27%, respectively, of the Fund’s long-term investments of \$625 million. Long-term investments were comprised of MLPs and MLP

Affiliates (51%), U.S. and Canadian Royalty Trusts (12%), Marine Transportation (8%), Coal (2%) and Energy Debt (27%).
