**KAYNE ANDERSON MLP INVESTMENT COMPANY
ANNOUNCES ITS NET ASSET VALUE AT JANUARY 31, 2006**

LOS ANGELES, CA – February 1, 2006 – Kayne Anderson MLP Investment Company (the “Company”) (NYSE: KYN), today announced its net asset value at January 31, 2006.

At January 31, 2006, the Company’s net assets were \$961 million and its net asset value per share was \$25.67, based on 37.4 million shares outstanding.

At January 31, 2006, the Company’s total assets were \$1.45 billion and long-term investments were \$1.36 billion. The Company’s ten largest holdings by issuer (exclusive of short-term investments) at January 31, 2006 were:
