**KAYNE ANDERSON MLP INVESTMENT COMPANY
ANNOUNCES ITS NET ASSET VALUE AT NOVEMBER 30, 2006**

LOS ANGELES, CA – December 1, 2006 – Kayne Anderson MLP Investment Company (the “Company”) (NYSE: KYN), today announced its net asset value at November 30, 2006.

At November 30, 2006, the Company’s net assets were \$1.1 billion and its net asset value per share was \$28.99, based on 38.1 million shares outstanding.

At November 30, 2006, the Company’s total assets were \$1.7 billion and long-term investments were \$1.7 billion. The Company’s ten largest holdings by issuer (exclusive of short-term investments) at November 30, 2006 were:
